a) Institutional Policy ER-1: Emergency Rule – COVID-19 Response (new)

Of note, the Emergency Rule – COVID-19 Response policy was originally named Institutional Policy GA-1 as indicated on the Committee agenda; however, the emergency rule was renamed prior to the June 5, 2020 committee meeting to Institutional Policy ER-1.

Jeffrey Shawver, Vice President for Legal & Governmental Affairs and General Counsel, presented to the Committee Institutional Policy ER-1: Emergency Rule – COVID-19 Response as a new emergency rule. Mr. Shawver stated the

proposed emergency rule provides a guideline for WVSOM's response to the COVID-19 pandemic and how WVSOM will proceed with the reopening of WVSOM and other operational functions affected by the pandemic. Committee members presented questions regarding how the term of the rule would work.

It was moved by Sherri Miller, and seconded by Dr. Belt, to approve the new Institutional Policy ER-1: Emergency Rule – COVID-19 Response and to present the new rule to the Board of Governors for approval.

Motion Carried Unanimously.
