DO 14-1. Authority

W. Va. Code § 18B-1-6

DO 14-2. Introduction

This policy defines the requirements of the West Virginia School of Osteopathic Medicine ("WVSOM") for promotion of students as they relate to passage of the Comprehensive Osteopathic Medical Licensing Examinations ("COMLEX").

DO 14-3. Definitions

- 3.1 "NBOME" refers to the National Board of Osteopathic Medical Examiners.
- 3.13.2 "COMLEX Level 1" means the problem- and symptom-based assessment of basic medical sciences knowledge administered by NBOME("CL-1") refers to the first examination in the COMLEX series administered by NBOME.
- 3.23.3 "COMLEX Level 2-CE" means the cognitive examination (CE) of clinical skills administered by NBOME("CL-2") refers to the second examination in the COMLEX series administered by NBOME.
- 3.4 "COMLEX Prep Track" Preparation Courses" ("CPC") means the form of remediation and help defined in association with failure of COMLEX Level 1 or COMLEX Level 2-CE. Different forms of COMLEX Prep Track are used depending upon the circumstances of the failure refers to required courses for all students preparing for CL-1 ("CPC-L1") or CL-2 ("CPC-L2").
- 3.5 "COMLEX Retake Courses" ("CRC") refers to a required course for any student who does not pass CL-1 ("CRC-L1") or CL-2 ("CRC-CL2)".
- 3.6 "COMSAE" refers to Comprehensive Osteopathic Medical Self-Assessment Examinations practice examination created by the NBOME.
- 3.7 "Qualifying Exam" is a proctored exam approved by the Director of ONB or the Dean used to determine whether a student may take CL-1 or CL-2. A qualifying exam may include, but

- is not limited to, one or more specifically designated COMSAEs, an exam available through a commercial board preparation company, or an in-house exam.
- 3.8 "Dean" refers to the WVSOM Vice President of Academic Affairs and Dean.
- 3.9 "ADCE" refers to the Associate Dean of Clinical Education.
- 3.10 "ADPE" refers to the Associate Dean of Preclerkship Education.
- 3.33.11 "SPC" refers to the "Student Promotions Committee", which is advisory to the ADPE, ADCE, and Dean.
 - "NBOME" means the National Board of Osteopathic Medical Examiners.
- 3.53.12 "OSCE" means the Objective Structured Clinical Examinations administered by the West Virginia School of Osteopathic Medicine.

DO 14-4. COMLEX Level 1 Requirements

- 4.1 Students must take COMLEX Level 1 to begin Year 3 clinical rotations, and must pass it to qualify to begin Year 4 clinical rotations. Students must take CL-1 to begin Year 3.
- 4.2 Students must successfully complete all Year 1 and Year 2 courses, all required assignments, pass the Year 2 OSCE, and complete Level 1 readiness requirements as set forth in WVSOM's Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination—Passage of COMLEX, to be eligible to take COMLEX Level 1. To be eligible to take CL-1, students must successfully complete all preclinical academic requirements and readiness requirements as set forth in WVSOM's Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination—Passage of COMLEX.
 - 4.2.1 All students are required to take COMLEX Level 1<u>CL-1</u> within WVSOM's exam window as set forth in WVSOM's procedure on COMLEX examinations Procedure for Institutional Policy DO-14.
 - 4.2.2 Students may not take COMLEX Level 1CL-1 on a date that conflicts with an academic activity required by WVSOM, unless excused by the Associate Dean for Predoctoral Clinical Education ADCE.
- 4.3 Failure to Take COMLEX Level 1
 - 4.3.1 Students who do not take <u>COMLEX Level 1CL-1</u> within the exam window will not be allowed to <u>continue on begin elinical</u>-rotations <u>unless a deferment has been granted</u> by the <u>Vice President for Academic Affairs and Dean and will be referred to the SPC for failure to meet academic standards</u>.
 - 4.3.2 An unexcused failure to take COMLEX Level 1 will result in the student being placed on Academically at-Risk Category 1 and possible disciplinary action.
- 4.4 Failure of COMLEX Level 1

- 4.4.1 For a first failure of COMLEX Level 1, students will be classified as Academically-at-Risk Category 1. Second or subsequent failures will result in students being placed on Academically-at-Risk Category 2. Students will be classified as Academically-at-Risk Category 1 for a first failure of CL-1. Students will be classified as Academically-at-Risk Category 2 for subsequent CL-1 failures.
- 4.4.2 All students who fail COMLEX Level 1CL-1 will be placed on the COMLEX Prep Track as set forth in Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination Passage of COMLEX.

DO 14-5. COMLEX Level 2-CE Requirements

- 5.1 Students must pass COMLEX Level 2-CE as a requirement for graduation take CL-2 to begin Year 4.
- 5.2 Students To be eligible to take CL-2, students must pass COMLEX Level 1 CL-1, complete all Year 3 requirements, and all readiness requirements as set forth in Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination Passage of COMLEX., pass all Year 3 courses, successfully complete all required assignments, pass the Year 3 OSCE, and complete Level 2 readiness requirements as set forth in Procedure for Institutional Policy DO-14 to be eligible to take COMLEX Level 2-CE.
 - 5.2.1 All students are required to take COMLEX Level 2-CECL-2 within WVSOM's exam window as set forth in WVSOM's procedure on COMLEX examinations Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination Passage of COMLEX.
 - 5.2.2 Students may not take <u>COMLEX Level 2-CECL-2</u> on a date that conflicts with an academic activity required by WVSOM, unless excused by the <u>Associate Dean for Predoctoral Clinical Education ADCE</u>.
- 5.3 Failure to Take COMLEX Level 2-CE
 - 5.3.1 Students who do not take COMLEX Level 2-CECL-2 within the exam window will not be allowed to continue on clinical rotations unless a deferment has been granted by the Vice President for Academic Affairs and Deanand will be referred to the SPC for failure to meet academic standards.
 - 5.3.2 An unexcused failure to take COMLEX Level 2-CE will result in the student being placed on Academically-at-Risk Category 1 and possible disciplinary action.
- 5.4 Failure of COMLEX Level 2-CE
 - 5.4.1 For a first failure of COMLEX Level 2-CE, students will be classified as Academically-at-Risk Category 1. Second or subsequent failures will result in students being placed on Academically-at-Risk Category 2. Students will be classified as Academically-at-Risk Category 1 for a first failure of CL-2. Students will be classified as Academically-at-Risk Category 2 for subsequent CL-2 failures.

5.4.2 All students who fail <u>COMLEX Level 2-CECL-2</u> will <u>be placed on the COMLEX Prep Track-complete a CRC</u> as set forth in Procedure for Institutional Policy DO-14: Promotion Requirement National Board Examination – Passage of COMLEX.

DO 14-6. Number of Overall COMLEX Failures

- 6.1 Students will be academically dismissed if they exceed two COMLEX failures on any one exam type (COMLEX Level 1 or COMLEX Level 2-CE) do not pass CL-1 or CL-2 on their third attempts.
- 6.2 Students will be academically dismissed if they exceed four COMLEX failures overall.
- 6.36.2 Academic dismissals under this Section 6 are not appealable under Section 78.

DO 14-7. Appeal

Except for academic dismissals under Section 6, requirements found in this policy that constitute an academic sanction may be appealed under WVSOM's policy on appeal of academic dismissal and academic sanctions.

DO 14-8. Implementation of Policy

This policy will be implemented using applicable WVSOM policies and procedures, including WVSOM's procedure on COMLEX examinations.
