version moving forward and was circulated for the required 30-day comment period. No comments were received. Mr. Shawver also noted that procedures will be effective concurrently with the policy.

It was moved by Sherri Miller, and seconded by Dr. Belt, to approve the revised Institutional Policy GA-14: Title IX, Sexual Harassment, and Discrimination and to present the revised policy to the Board of Governors for approval.
